Rural Municipality of Shellbrook 493 Road Allowances

All public roads (including lanes, streets and original road allowances) are owned by the Crown. Other than provincial highways, municipalities are given the authority to direct, control and manage all streets and roads within their municipality.

A municipality has discretion over where and when roads may be built depending on its budget, and over the construction and maintenance standards. No law exists that requires a municipality to build any road. Each situation is unique and subject to a municipality's discretion.

It is the municipalities position that all road allowances excluding those that have been sold or leased are to remain open. Passage through road allowances must be allowed regardless if the road allowance is maintained by the municipality or not. Cropping or fencing of a road allowances may be permitted; unauthorized restrictions may be removed by the municipality.

The Municipality will maintain a gravel surface on all roads that service a permanently occupied residence, roads that the Municipality has designated as school bus routes, and roads that have significant traffic counts.

Roads that only provide access to farmland, granaries, or farm sites without permanently occupied residences will not be graveled at the Municipality's expense.

If any Individual decides to maintain any municipal road that is not regularly maintained by the municipality, it must be done at their own expense with the Municipalities approval and at an approved standard

If you would like to address Council at a Council meeting, please Contact the R.M. office at least one week prior to the meeting, and state the topic (with a brief description) you wish to address. Council meeting are held the first Wednesday of each month.
